

DESCRIPTION & APPLICATIONS

The 390 and 390A tie clasps are designed to retain any two of the following Electro-Voice lavalier microphones: CO90, CO90E, CO100, CO100E, CS200 and CS200E. The 390 or 390A tie clasps should be used when conditions call for the use of two lavalier microphones on one performer. Use of a single clasp prevents microphone-to-microphone impact, allows the performer to easily position the microphones and presents a less obtrusive appearance.

Many television stations employ dual lavaliers as a means of guaranteeing an essentially zero chance of on-the-air failures. The finish of the 390 is dull chrome plate; the finish of the 390A is camera black. These flat surfaces eliminate undesirable reflections that can produce glare when on camera.

The textured chrome surface of the 390 clasp can be painted, if desired, with readily available cans of spray paint. Later, the original finish can easily be restored by washing the 390 in a suitable paint solvent. (The finish of the 390 is unaffected by solvents.)


The black finish of the 390A is designed to match the CO100 and CS200. While the 390A may be painted to change the color, this is not recommended because it is not a reversable process (solvents used to remove the second finish are very likely to damage the original finish).

To insert a microphone into the clasp, squeeze the appropriate spring retainer, which will increase the loop diameter to the point that the microphone will easily enter the loop. Push the microphone from beneath the spring loop until the loop is over the groove in the microphone designed to receive it. Once properly seated into the retention groove, the clasp's spring positively retains the microphone.
