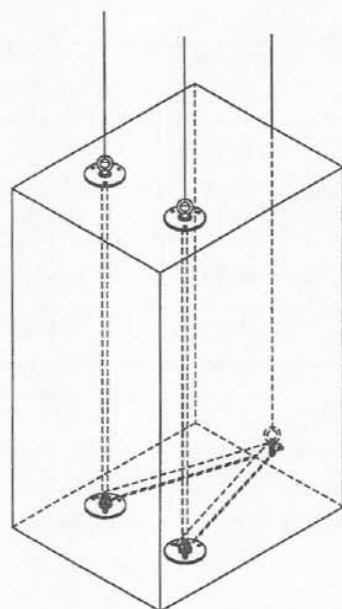
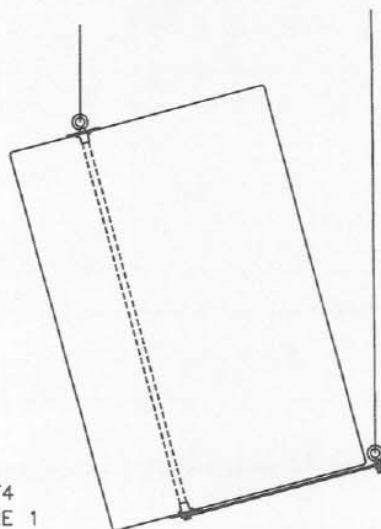

Description

The Electro-Voice HST series of hanging systems provide a certified and flexible method of suspending many popular Electro-Voice T-Series™ loudspeaker systems.

Equipment Required for Installation

- ¾-in. socket wrench
- 1-¾-in. hole saw
- adjustable wrench
- power screwdriver (#2 Phillips head)

Introduction

In common with any suspension system, the HST system is only as strong as its weakest link. The installer must ensure the top mounting points have sufficient load bearing capability to safely suspend the cabinet. The initial support cables or chains should be as close to vertical as possible and never more than 30° from vertical. None of the chains or cables should touch or rub against the cabinets. Local codes and regulations, if they exceed Electro-Voice's recommendations, should be followed at all times. Electro-Voice recommends that a safety fac-

tor of at least 6:1 should be adopted. When properly used, the Electro-Voice HST4 kit provides a safety margin of more than 10:1 when used to suspend a T351 or T180 loudspeaker system.

It is the installer's responsibility to ensure the HST system has been installed correctly. Electro-Voice strongly recommends that all suspended items be inspected at least once a year and any damaged parts be replaced immediately. All HST kits follow the same principles. Put minimum stress on the cabinet and make each cabinet hang independently of any other device.

Suspending The Electro-Voice T351 Stage System or T180 Subwoofer

The following is the recommended method for suspending the T351 Stage System or T180 Subwoofer (see Figure 1).

Two tubes pass vertically through the cabinet and each is secured to it via two oversize cast brackets. Two cold forged eyebolts are screwed into the "top" two brackets. (For mounting flexibility, either end of the system may be considered the top.) The two

pull-up straps are attached to the "bottom" brackets with the supplied ¾-in. bolts and lock washers. The pull-up straps are fastened to each other with an eyebolt and locking hex nut. This makes a single rear pull-up point for aiming the system. Suitably rated chain or aircraft cables can then be used to suspend and aim the cabinet. The center of gravity is arranged so the enclosure is directed towards the ceiling. In order to provide a downward or horizontal projection angle, the pull-up point must be used.

If multiple cabinets are to be suspended, each system requires the appropriate HST kit and systems should not be suspended from each other. The tubes run top to bottom through the enclosure. The eyebolts must be connected to the chain or aircraft cable using suitably rated connectors such as shackles or threaded chain connectors.

Electro-Voice recommends that T-Series™ speaker systems not be suspended from one another when using HST Series system kits even though the designated weight limit may not be exceeded.

Installation Instructions

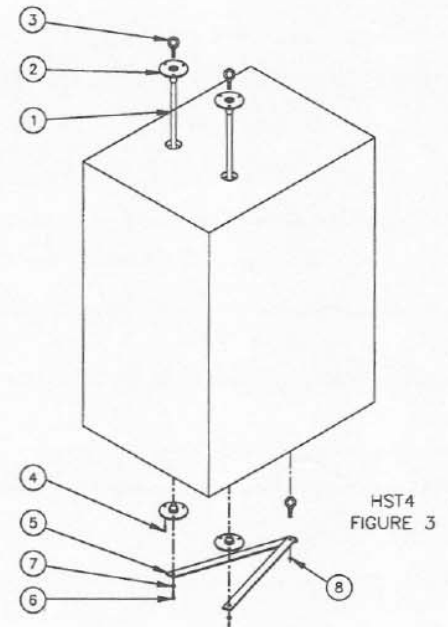
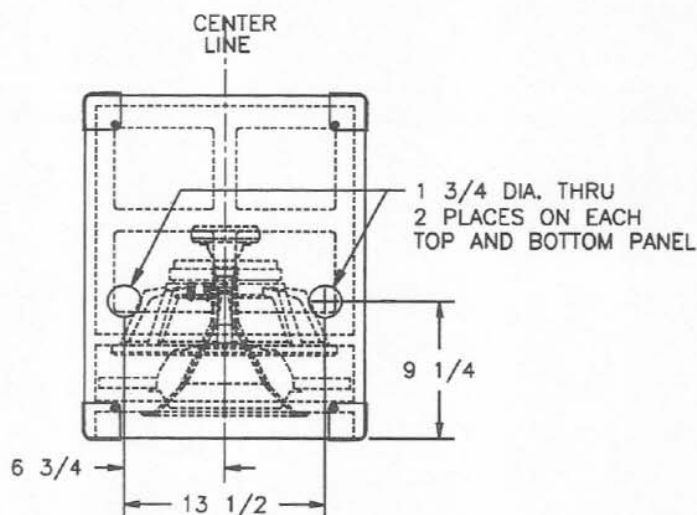
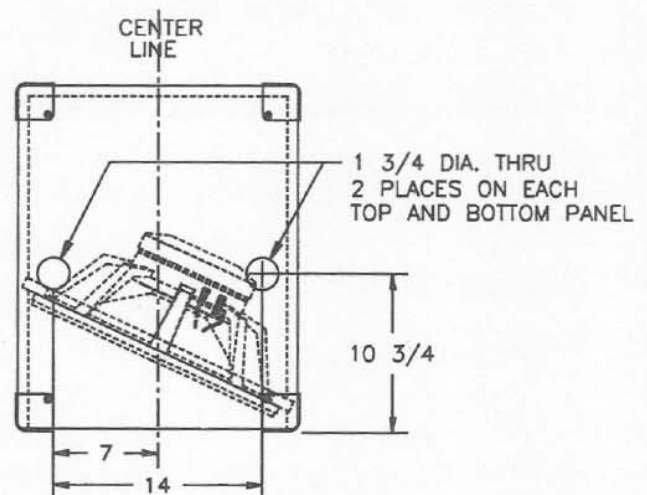


Figure 2—Drilling guide for T351

1. See Figure 2 for correct locations of the four holes to be drilled into the T351 stage system or T180 subwoofer enclosure. Mark the hole positions on the top and bottom of the cabinet. It may be desirable to mask the ends of the enclosure while drilling to keep sawdust from settling into the carpet.
2. Use a 1-3/4-in. hole saw to cut holes in the cabinet at the designated positions (two on the top panel and two on the bottom panel).
3. Screw one threaded tube firmly into one round hanging bracket. These parts may already be assembled when you remove them from the shipping carton.
4. Pass the tube through the cabinet being careful to steer clear of the woofer and other internal components.
5. Screw the remaining hanging bracket onto the exposed thread of the tube. Screw down firmly using nut head (on hanging bracket) and socket wrench.
6. Use a power screwdriver to screw the

wood screws into each bracket (three in each bracket). With carpet-covered enclosures, pilot holes are not generally necessary. With a reasonable amount of care, the screws will "self-center".

7. Repeat steps 3 through 6 for remaining tube, brackets and screws.
8. Test to be sure the cabinet does not leak from around the hanging bracket by applying a 50 Hz sine-wave signal to cabinet.
9. Screw the eyebolts firmly into the "top" mounting brackets.
10. Connect the two pull-up straps together loosely using the third eyebolt and the 3/8-in. locking nut. Do not tighten yet.
11. Connect the pull-up straps to the "bottom" two mounting brackets using the 3/8-in. bolts and lock washers. Note that the eyebolt should be "pointing up".
12. Now tighten the third eyebolt and locking nut on the pull-up straps (referred to in step 10).

Double check all mechanical connections. The speaker system is now ready to be suspended.

Figure 3—Exploded view of T351 and HST4 parts
