- Wall or ceiling mounting possible

SPECIFICATIONS:

Wall/Ceiling Mounting Holes:

Three in-line, 6.35-mm (0.25-in.) diameter clearance holes, centers spaced 15.2-cm (6.0-in.) apart

Enclosure Mounting Holes:

Two 6.35-mm (0.25-in.) diameter clearance holes on the ends of the bracket

Material:

Hot-rolled steel

Finish:

Black powder coat

Parts Supplied (see Table 1):

(two) 1/4-20 cap screws (wood enclosure) or M-6 metric screws (plastic enclosure)1

Friction pads (two) Nylon washers (two)

Net Weight:

1.02 kg (2.25 lb)

Shipping Weight:

1.47 kg (3.25 lb)

WALL OR CEILING MOUNTING

Refer to Figure 1 and Table 1 for the following steps:

- 1. Attach the U-bracket (A) to the wall or ceiling using fasteners that are suitable for the wall or ceiling material (not supplied).
- Remove the paper backing from one of the friction pads (D) and attach these to the U-bracket as shown.
- 3. Free the two holes on the top and bottom of the S-60A using a sharp knife to cut the plastic. (See S-60A data sheet for the exact position of these holes.)
- 4. Ensuring that the nylon washer (C) is mounted between the U-bracket and the

fixing screws, mount the S-60A to the Ubracket with either the supplied 1/4-20 cap screws (B-1) (for mounting to a wood enclosure) or the M-6 metric screws (B-2) (for mounting to a plastic enclosure). (Note: if used with the older version S-60 (not "A" version), use the M-6 metric screws regardless of the enclosure material.)


5. Rotate the speaker so that the input terminal is accessible and attach the wires. Position the speaker for the desired angle and tighten the screws sufficiently so that the speaker does not inadvertently rotate.
