

SPECIFICATIONS:

Wall/Ceiling Mounting Holes:

Three in-line, 6.35-mm (0.25-in.) diameter clearance holes, centers spaced 15.2-cm (6.0-in.) apart

Enclosure Mounting Holes:

Two 6.35-mm (0.25-in.) diameter clearance holes on the ends of the bracket

Material:

Hot-rolled steel

Finish:

Black powder coat

Parts Supplied (see Table 1):

U-bracket

1/4-20 cap screws (two)

Friction pads (two)

Nylon washers (two)

WALL OR CEILING MOUNTING

ceiling using fasteners that are suitable for the wall or ceiling material (not supplied).

- Remove the paper backing from one of the friction pads (D) and attach these to the U-bracket as shown.
- 3. Free the two holes on the top and bottom of the S-80A using a sharp knife to cut the plastic. (See S-80A data sheet for the exact position of these holes.)
- 4. Mount the S-80A to the U-bracket with the supplied cap screws (B), ensuring that the nylon washer (C) is mounted between the U-bracket and the cap screws.
- 5. Rotate the speaker so that the input terminal is accessible and attach the wires. Position the speaker for the desired angle and tighten the screws sufficiently so that the speaker does not inadvertently rotate.

CAUTION:

Due to the weight of the S-80A speaker system, it is imperative that the S-80MBA bracket be properly secured to the wall or ceiling. The choice of fastener (not provided with bracket kit) will be determined by the material and construction of the mounting surface.
